Course Description: This course is a study of the functions performed in the American system of state governments, with special reference to the development of governance in Texas and its Constitutions. This course satisfies the Legislative requirements for teacher certification.

Course Purpose: Government 2306, as taught at South Plains College, is a reading intensive course designed to acquaint the learner with the origin and development of the Texas Constitution, structure and powers of state and local government, federalism and intergovernmental relations, political participation, the election process, public policy, and the political culture of Texas. This course meets the statutory requirements as set forth by the state of Texas.

<u>Methods to Attain Learning Outcomes:</u> The following suggestions will help you better understand the material, and improve your knowledge of Texas government.

- 1. Review the learning outcomes (Focus Questions) at the beginning of each chapter.
- 2. Read the chapter carefully at least twice.
- 3. Outline the chapter to focus on the authors' organization of the chapter, and discover what he believes to be the most import points in the chapter.
- 4. Review all graphs and charts.
- 5. Review all the key terms.

<u>Study Guide:</u> A course study guide is provided for you under the Course Content icon, located in the top left hand corner of the home page. The study guide will provide study questions for each chapter, to help you better understand the major points in each chapter. While the study guide will not cover every question on the test, it will assist you in answering most of the questions.

<u>Discussion Board:</u> A discussion board is required by all South Plains College online classes. In the discussion board you will have the opportunity to introduce yourself to the class, and discuss topics related to that week's reading material. There will be 3 topics for the Discussion Board this semester. The discussion will be open on Monday and close on Friday. I will announce when the discussion topic is open for the week.

Each Discussion Board is worth 15 points or .5% of your final average. A discussion post must be at least 3 or 4 sentences, and provide thoughtful analysis of the material in that week's chapter. Any post, which is too brief, shows little thought, or is mostly BS will receive no points. Unfortunately, most students believe the Discussion Board is to give them free points, and their posts seldom receive any credit. Posts will receive either full credit or no credit; I will not give partial credit on discussion posts. A comment of "God Job" means you have received full credit. Please remember that it is okay to have different opinions on any discussion topic. All I ask is that you respect each other's opinions and be civil in your responses. It is not acceptable to use profane or abusive language in the discussion board. I will monitor all discussions to make sure everyone behaves in a proper manor.

Exams and Grading (Read this section carefully)

1. Exams: You will have 10 chapter tests and a final exam. The best 10 scores will be counted towards your grade (your lowest test score will be dropped). Each test will have 25 multiple choice and true/false questions worth 4 points each, for a total of 100 points. You must take the test by 11:59 PM on the assigned date. Otherwise, you will receive a zero for the test. All tests will be timed, just as if you were in class, so make sure you know the material before you take the test. You will not have time to look for the correct answers in the book. Tests will last 25 minutes.

Note carefully: once you click on "Begin" you must complete the test in its entirety. Please be sure to click on the save button after you answer each question. Otherwise, your answer will not be saved, and you will receive no credit for that question. If the test is not completed within the allotted time, you will receive a zero for that grade. Please do not wait until the last second to click "Save and Submit" for the test. Students, who have tried this, have found that the computer will not accept their test.

Computer malfunctions happen. If you have a computer malfunction during a test, it is considered an incomplete test, and I will use your one drop for that test. There are no make-up tests.

All tests are available on the first day of class. Any test may be taken before the scheduled test date, but no test may be taken after the scheduled test date.

2. <u>Final Exam:</u> All government classes have a writing requirement. The final exam will meet your writing requirement for this course. The final exam will be an essay over what you have learned in this course. In a one or two page essay, you will be required to list three things you have learned in this course. Explain in your own words why you think these things are important to Texas government. Make sure not all three things come from the same chapter. Your essay will be graded on how well you understand the material, and how well you present your ideas. The final essay will not be timed, so please take the time to proof read your essay to make sure it can be easily understood by the reader, using proper grammar. In Blackboard, essays are single spaced with one inch margins. If you copy and paste a Word document into Blackboard for your final essay, make sure it meets these requirements. Just remember, if you try to give me the least amount possible, by double spacing with wide margins: it's your grade!

3. Grading:

- a. You will take 11 exams each worth 100 points.
- b. Your grade will be an average of the best 10 tests. (I will drop your lowest grade, either a chapter test or the final exam. If you are happy with your grade at the end of the semester, you do not have to take the final exam.)
- c. Grading scale: A = 100-90, B = 89-80, C = 79-70, D = 69-60 & F = below 60
- d. Exams will not be curved.

<u>Chapters for Reading Tests</u>: You will take a test on the following 10 chapters and a final exam. See your Test Schedule for test dates. <u>Test may be taken before the assigned test date, but not after.</u> Anyone failing to take a test by the assigned date will receive a <u>zero</u> for that test score.
