A. COURSE DESCRIPTION

Introduction to intermediate nursing skills and knowledge needed to provide care for the adult patient. Designed to provide the student with an overview of nursing and the role of the nurse as a provider of patient-centered care, patient safety advocate, member of the health care team, and a member of the nursing profession. The course allows the student to apply nursing concepts and develop clinical skills in a variety of settings, including but not limited to clinical lab, simulation, focus groups and peer review.

B. STUDENT LEARNING OUTCOMES

At the completion of the course, the student will be expected to:

- 1. Understand and apply appropriate and evidence based techniques when administering medications.
- 2. Perform basic nursing skills competently with individual clients in structured settings.
- 3. Provide cost effective care in the clinical setting.
- 4. Utilize information technologies to enhance knowledge base, retrieve information to support nursing practice and document nursing actions.
- 5. Organize, prioritize and modify care using the nursing process.

Upon satisfactory completion of RNSG 1144, the student will meet the following:

F. STANDARDS OF PRACTICE

- 1. The SPC ADNP policy must be followed. Refer to the SPC ADNP Nursing Student Handbook to review this policy. In addition, refer to the attendance policy found in the South Plains College Catalog.

- 3. Students are expected to attend all scheduled lab days; including but not limited to, Boot camp and Practicum. In the event of illness the student must notify the instructor prior to missing class.
- 4. The student is responsible for coordinating with the lab director for skills practice and recording of any skill. The student must notify the lab director prior to scheduled appointment, if they are unable to keep the appointment. Failure to notify lab coordinator will result in 10% grade reduction of required taping.
- 5. If the student misses 3 hours of skills/lab the student may be dropped from RNSG 1105. The student may be referred to the Health Occupation Dean. If the student is in good standing, has properly notified the instructor when absent, and resolved the problem causing the absence, the course leader has the option to allow the student to continue in the course.
- 6. Extenuating problems such as surgery, severe illness, pregnancy, delivery, or immediate family emergencies should be communicated to faculty as soon as possible, for consideration on continuance in RNSG 1144.
- 7. Students are required to wear scrubs when in the lab. <u>Full SPC uniform is required for any testing (practicum 1, pharmacology taping, and remediation)</u>. Failure to dress appropriately for lab days will result in professional standard deductions.
- 8. Practicum 1 and pharmacology tapings are considered testing and should remain <u>confidential</u>. HIPAA violations will result in professional standard deductions and possibly disciplinary action.
- 9. Additional remediation may be required at any time at the faculty's discretion.

H. ASSIGNMENTS

ATI LESSONS

Student will complete the Nursing Concepts and Priority Setting Framework ATI lesson in ATI. Please see class schedule for due dates. Students must complete the module and posttest. Failure to complete ATI lessons by the due date and time will result in professional standard deductions on final course grade.

ATI Skills Modules

Students will be required to complete the ATI pretest, learning module and posttest for each skill assigned. Failure to complete pretest or learning module will result in a **10-point** deduction on the final posttest. Pretest and lesson must be completed by 2300 the day prior to lecture. Posttest must be completed by 2300 on the day of lecture. ATI posttests will account for <u>15%</u> of the final course grade. Students must receive cumulative of <u>77%</u> on posttest to pass course. Failure to complete the skills modules by the due date will result in a zero.

Peer Review

Student will complete a peer review and provide feedback on a peer's remediated skill. Students must complete the peer review together in order to provide meaningful feedback. Failure to complete peer review and remediation will result in a zero for the assigned skill. Refer to section **K** for more peer review information.

Boot Camp

Students will participate in hands on learning opportunity in the SPC skills lab in Levelland. Small, instructor led focus groups will address required nursing skills for RNSG 1144. Students will have opportunities to practice, ask questions and gain confidence in basic nursing skills. Attendance is mandatory.

Student Injections

Students will administer an Intramuscular (IM), Intradermal (ID) and Subcutaneous (SQ) injection to another student. This learning opportunity will be completed in instructor led focus groups. Students must sign consent before injections can be administered.

Practicum

Students will be individually tested by faculty on skills acquired during boot camp. Students must complete assigned clinical practice hours by due date or the student will receive a zero for the practicum. The student will be graded based on the grading rubrics located in Blackboard under Practicum 2 folder. If a 77% is not achieved the student will be required to remediate the failed skill. Refer to section I for more information. Practicum 2 will account for 40% of the final course grade.

Final Comprehensive Practicum

Final comprehensive practicum will include all skills learned in the first semester. Students will perform skills, administer medications, and complete a physical assessment. Students must receive at least a 77% on final practicum medication rubrics in order to successfully pass RNSG 1144. Students will be observed by instructor and graded based on rubric found in Blackboard under the final practicum folder. Skills completed in the final practicum cannot be remediated. The final comprehensive practicum will account for 45% of the final course grade.

I. GRADING POLICY

Students must receive a cumulative grade of 77% or better to pass RNSG 1144. Failure to obtain a cumulative grade of 77% will result in failure of RNSG 1144. If the student fails to receive a 77% on any skill during practicum, the student will be given one opportunity to remediate with the exception of the final comprehensive practicum. Students will not be allowed to remediate if grade meets or exceeds 77%.

The grade for this course will be determined upon completion of the following components:

Course grades are based on the following scale:

A = 90-100%

B = 80-89.99%

C = 77 - 79.99%

Students must have previously passed RNSG 1105 and score a cumulative of 77% on all required course work with the exception of pharmacology.

Students must achieve a 77% or greater on each final pharmacology grading rubric to pass the course.

Additional Practice:

At any time a faculty member can require a student to complete additional practice in the simulation lab to ensure student and client safety in clinical. If not completed, the student will receive deductions on professional standards.

J. SKILLS REMEDIATION POLICY

If a skill must be remediated the maximum grade that can be achieved is an 87%. The first attempt will be peer reviewed and critiqued based on grading rubric. The peer reviewed rubric must be completed before the final attempt is viewed by instructor. Failure to submit peer reviewed rubric will result in an additional 7% grade reduction resulting in a maximum grade of 80%. The second and final attempt will be submitted and graded by instructor. The final video must be completed by the due date. Late videos will not be accepted. Failure of the student to submit video by due date will result in a **0%** for remediated skill. Students may elect to submit their peer review for their final grade if desired.

The final attempt will be the final grade for the skill based on grading rubric. This will stand as the final grade for the remediated skill. This grade can be less than 77% (with the exception of pharmacology) and will be averaged in the final grade for RNSG 1144. It is the responsibility of the student remediating to arrange adequate time for peer review and final attempt.

K. PEER REVIEW PRACTICUM REMEDIATION

Students selected for peer review will provide quality feedback to the student requiring remediation. Failure to arrange viewing time, provide feedback, or accurately grade based on provided rubric, will result in a 5% grade deduction. Grade deduction will be applied to reviewer's skill.

P. CAMPUS CONCEALED CARRY

The following Penal Code pertains to all hospital owned property such as clinics, physician's offices, ambulances, and ambulance stations.

Texas Penal Code - PENAL § 30.06. Trespass by License Holder with a Concealed Handgun states that an individual cannot carry a handgun (concealed or open carry) on the premises of a hospital licensed under Chapter 241, Health and Safety Code, or on the premises of a nursing facility licensed under Chapter 242, Health and Safety Codes, unless the license holder has written authorization of the hospital or nursing facility administration.

Texas Penal Code - PENAL § 30.07. Trespass by License Holder with an Openly Carried Handgun states that an individual cannot carry a concealed handgun on the premises of a hospital licensed under Chapter 241, Health and Safety Codes, or on the premises of a nursing facility licensed under Chapter 242, Health and Safety Codes, unless the license holder has written authorization of the hospital or nursing facility administration.

Q. TITLE IX PREGNANCY ACCOMODATIONS
