GENERAL COURSE INFORMATION:

Course Level: Advanced

Course Description: Instruction in the artistry of hair design. Topics include theory, techniques, and application of hair design.

End-Of-Course Outcomes: Demonstrate workplace competencies related to the artistry of hair design and perform professional skills of hair design.

Specific Goals/Objectives of this course are to:

- Identify the terminology related to hair structure, growth, and distribution.
- Exhibit workplace competencies related to the artistry of hair.
- Demonstrate the proper application of hair design.

Course Competencies: Upon successful completion of this course, the student will:

- Perform analysis of hair structure.
- Confer and organize analysis of hair growth.
- Differentiate in hair distribution.

- Use information and tools in the artistry of hair.
- Produce hairstyles using elements of good hair design.

Academic Integrity:

Late work is generally not acceptable; however special consideration is subject to instructor discretion whether or not the work is acceptable.

The course instructor will introduce the college grading policy and method to determine G.P.A. during the course of instruction. The Texas Department of Licensing and Regulation demands an overall minimum grade of 70; therefore this course requires the same. An overall grade below 70 is considered an F.

CSME 1451 students will demonstrate competencies in the following tasks:

- Understanding and performing analysis of hair structure.
- Understanding, demonstrating and explaining terminology related to hair structure, growth, and distribution.
- Complete written assignments related to theory and knowledge of hair structure.
- Exhibit the use of information and tools related to the artistry of hair.
- Create hairstyles using elements of correct hair design (proportion and balance).
