COURSE DESCRIPTION: This course is a study of Growth and Development which is a study of the basic aspects of growth and development throughout the lifespan. The focus will be on growth and development of the individual body, mind, and personality as influenced by the environment.

## **B.** Class Attendance Policy

There are no excused absences in the Vocational Nursing Program. Roll is taken for each class. A student who is not present when roll is checked is "absent." A student must sign in for each class; if a student fails to sign in, the student is marked "absent." Students are not allowed to disrupt the class for tardiness. A tardy student may come into the classroom following a break. The student must sign in, but the student will still be counted absent. A student who leaves before the end of class is counted absent. CLASSROOM ATTENDANCE: Learning is fostered in the classroom environment. Missing even one lecture/class activity can negatively impact student performance; therefore, classroom attendance is mandatory and students are accountable to attend and be on time for class.

# PLEASE REVIEW THE ATTENDANCE POLICY FOR EACH CLASS FOUND IN THE COURSE SYLLABUS.

Allowable absences per class will be two (2) absences per class except in the one-credit hour courses in which only one (1) absence will be allowed. Students should take an absence when they are truly ill (running fever, nausea/vomiting not due to pregnancy, diarrhea or some other communicable disease). A physician's release should be submitted when the student is treated by a physician. Students who exceed the allowable absence no longer meet the course criteria and must withdraw. Absences are recorded for the whole day if a class is scheduled for the whole day.

# C. Examination Policy

There will be 2 main Unit Exams plus a final exam in the classroom along with 4 online Davis Edge exams and one cumulative Davis Edge Final. You will need 2 of the (50) scantrons and 1 of the (100) scantrons. Students are expected to take all examinations for each nursing course. There are **NO** make-up exams for this course. No caps or hats may be worn during an exam. No backpacks or books are allowed in the room during an exam. Any long sleeves being worn must be rolled up during an exam. Cell phones are not allowed. If one rings during an exam this paper will be taken up and a grade equal to half of the possible points for that exam will be given regardless of which question you were on.

All Davis Edge exams and Final are due by the due date posted online, 11:59 PM Eastern time (10:59 PM Texas time). Please be aware of the time difference. No excuse will be allowed for not having them done on time, **NO EXCUSE!** This includes computer error, power outage, or anything beyond your control. You are highly encouraged to work on these on Fridays here at building 5 so that if such an error occurs, I am present in the building and might be a witness to the issue. All Davis Edge exams are timed and each exam is individually randomized on the question order so no 2 exams are alike in order to prevent groups working together or cheating.

In order to achieve a passing grade in VNSG 1133 200 Growth and Development, the student must achieve a minimum of 1290 points out of 1720 points (75 percent) from the Exam portion of the course.

#### **D.** Grading Policy

In the interest of consistency, all grades will be calculated as follows:

Unit exams will not be rounded up.

The Final course grades **ARE NOT** rounded up. i.e. -79.4 = 79.4.

The Final exam grade will not be viewable on blackboard.

The Final numerical course grade will not be viewable on blackboard.

Only the Final letter grade will be viewable on CampusConnect.

CampusConnect is the official grade of the course.

- 1. Grades are recorded on an Excel program that calculates the average of grades.
- 2. Each student should know current course averages for all classes.
- 3. Students must earn a minimum of 1290 points or a "C" for progression.
- 4. Students have the opportunity to review all grades as they are recorded. Should the student have any questions about a specific grade or specific test question, the student must schedule an appointment with the instructor before taking the next scheduled exam. If the student does not make an appointment prior to taking the next exam, then the assigned grade on the previous exam is final and may not be challenged at the end of the course. The final exam may not be reviewed.
