**A. GENERAL COURSE INFORMATION**

**B. COURSE DESCRIPTION (WECM):**

*Introduction to the nursing profession and its responsibilities, includes legal and ethical issues in nursing practice. Concepts related to the physical, emotional, and psychosocial self-care of the learner/professional. Discuss the personal adjustments essential to the development of the vocational nurse; identify the role of the licensed vocational nurse; and discuss the legal and ethical responsibilities in vocational nursing practice.*

**C. STUDENT LEARNING OUTCOMES (DECS):**

*The student will discuss the personal adjustments essential to the development of the vocational nurse. The student will also identify the role of the licensed vocational nurse and discuss the legal and ethical responsibilities in vocational nursing practice.*

*Following successful completion of this course, the student should be able to:*

1. Discuss the patient's Bill of Rights and explain the role of the nurse in regards to the patient's rights.
2. Define confidentiality and the nurse's responsibility to protect the patient.
3. Define ANA, LVN/LPN, NFLPN, NAPES, HMO, MEDICAID, MEDICARE, DRG.
4. Differentiate between ethical and legal.
5. Explain the function of the State Board of Nursing; the difference in permissive and mandatory licensure which applies to Texas.
6. Identify standards of vocational nurse practice that and the LVN code of ethics; identify decision making processes; identify lines of authority and accountability.
7. Identify unique customs and practices of various religions, beliefs, and cultures. Discuss how they influence healthcare.
8. Discuss legal aspects of nursing care including liability insurance, libel vs. slander in nurse-patient relationships, invasion of privacy, Good Samaritan Law, informed consent, "reasonable and prudent nursing", child abuse, and the nurse's role in risk management.
9. Explain the role of family and/or significant others in providing support to your patient.
10. Describe various therapeutic communication techniques.
11. Identify the roles and plans of other health care workers in relation to nursing care.
12. Discuss the historical evolution of professional and vocational nursing practice, the roles of professional and vocational nursing and the impact on health care today.
13. Identify behaviors which promote a positive image of vocational nursing, using self-evaluation of behaviors to improve nursing care.

**II. SPECIFIC COURSE/INSTRUCTOR REQUIREMENTS**

**A. REQUIRED TEXTBOOKS AND OTHER MATERIALS**

*Each student is encouraged to read the assigned chapter(s) prior to the beginning of each scheduled class period. Students should bring the above textbook to each scheduled class.*

*Power-point presentations are posted on Blackboard at the beginning of each semester. Updates and additional information may be posted through-out the semester at the discretion of the instructor. Students will be notified of changes via Remind message or an announcement posted on blackboard.*

**B. ATTENDANCE POLICY**

If more than four (4) hours are missed of class the student will be withdrawn from this 32 hour course. Three (3) tardies count as one (1) hour's absence.

**C. REMIND.COM**

Each student is encouraged to subscribe to remind.com for specific instructions and updates for this specific class. Once the student subscribes, should there be any changes or additions to the class schedule or material, a text message will be sent via remind so that all students are notified of the change.

**D. ELECTRONIC DEVICES**

Recording lectures, presentations, and discussions is **NOT permitted**. You may opt to use an e-reader instead of a traditional textbook, however if you are using your device for things other than assigned reading or assignments during class that causes other students to become distracted, you will be asked to put your device away or to refrain from bringing it to class.

**CELL PHONES ARE NOT ALLOWED DURING CLASS TIME!!!!** If you are caught texting during class, you will be asked politely once to refrain, after that you will be asked to leave the classroom and will not be allowed to return that class period. This will be counted as an absence.

**YOU MAY NOT HAVE YOUR ELECTRONIC DEVICE OR CELL PHONE WITH YOU WHEN TESTING!!!!** All students will be required to turn phones completely off or on silence during test. If your phone makes noise (either a ringtone or vibration) during a test, the student will be asked to turn in their test and leave the testing area. The test will be graded "as is" and that will be the score given for that specific unit exam.

**E. ASSIGNMENT POLICY**

All class assignments are to be completed and turned in on the designated date. Failure to complete assignments will result in a grade of "0". A grade of "0", when averaged with all grades, may result in an overall failing grade for the class.

All homework should be clocked in and placed in the basket on the counter at the beginning of class. Any homework turned in AFTER the beginning of class WILL be considered late and points will be deducted as per policy. Homework should ALWAYS be clocked in, whether on time or late. Assignments turned in after the assigned due date and time will have ten (10) points deducted from the grade for each scheduled class period that they are late.

Homework will not be accepted if it is more than three (3) scheduled class days late. If not submitted within this time frame, the student will receive a "0" for the assignment.

**F. GRADING POLICY**

Each Unit assignment will count as 20% of your grade. These scores will be averaged at the end of the course to make up your final grade. You must receive a 77 in this class to be admitted into the Vocational Nursing program.

Due dates for the unit assignments will be announced in class by the instructor. **All** unit assignments must be typed. Spelling, grammar, and neatness will be taken into consideration in grading. APA 6<sup>th</sup> Edition format is required. Students will be given advance notice of test dates. Should a student need to be absent on a test date, if arrangements are made **PRIOR** to the test, the faculty may reschedule the test. **If no attempt is made to contact the faculty prior to the test, no make-up test will be available.** The make-up test may be a different test OR may be a different test format than the test given on the scheduled date. **Should a student show up for class AFTER a test has started, they will NOT be permitted to take the test, and unless arrangements are made prior to the exam, no make-up test will be available.** For that reason, it is vital that students make it to class on time!

Scantrons will be made available to students by the faculty for testing purposes. Some tests may be “open-book”. Each student is encouraged to bring their book to every scheduled class period. Test format includes multiple choice, short answer, and essay type questions. Some tests may be given as a group test. With this test, the students will turn in a scantron with the name of all the group members. Once graded, each group member will be given the same score for the test.

All homework should be clocked in and placed in the basket on the counter at the beginning of class. ALL Homework assignments MUST be typed. Questions should be answered in paragraph form using complete sentences with appropriate grammar and spelling. ALL assignments should include a reference sheet and citations for references in the body of the paper(s) (when indicated). Students should follow APA, 6<sup>th</sup> Edition guidelines for proper format, citations, and references/bibliography. An abstract is NOT required for any writing assignments. The SPC library has GREAT resources if you are not familiar with APA guidelines.

A grading rubric is included for each of the homework assignments.

The assignment MUST be turned in at the beginning of class time on the date assigned or the assignment will be counted as late and ten (10) points will be deducted from the grade for every scheduled class day that the paper is late. Assignments will not be accepted after three (3) scheduled class periods have passed. The student(s) will receive a “O” for that assignment.

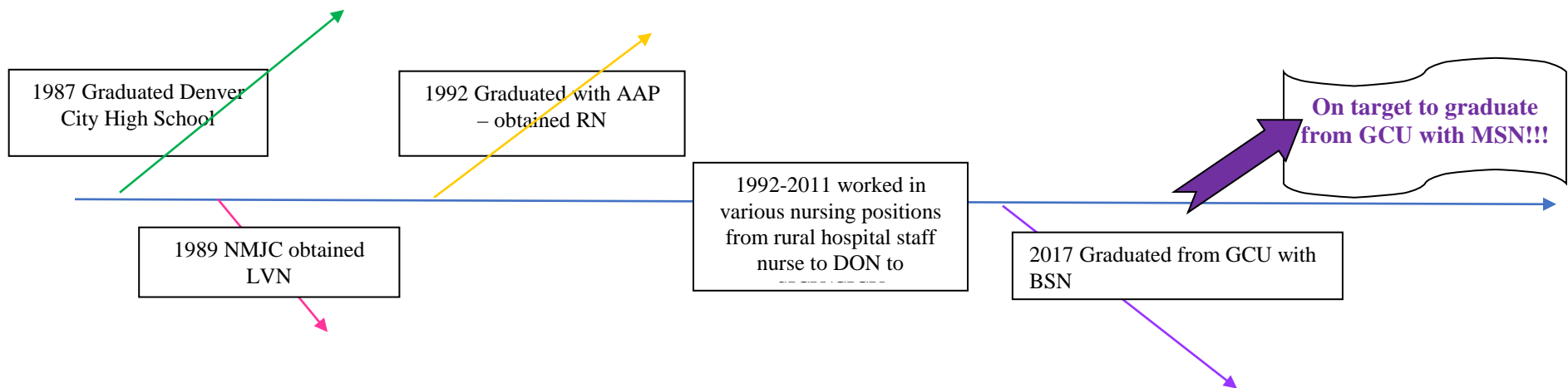
