#### **Textbook**

Students will use textbook and materials from CDEC 1319 as resources.

## **Attendance Policy**

- It is the student's responsibility to make arrangements for the practicum site, given instructor guidance.

- Each session will be documented daily in the practicum folder, with site supervisor's full signature.

- Students will be notified of the dates of (2) observations by the practicum instructor. It is the student's responsibility to be present for each scheduled observation. Absence will result in loss of credit.
- Students who find that they cannot successfully complete the course/practicum experience should withdraw from the course to protect overall GPA. Last drop date for this semester is July 18, 2019.
