### I. COVID INFORMATION

## A. <u>COURSE DESCRIPTION</u>

Personal and family accounts, budgets and budgetary control, bank accounts, charge accounts, borrowing, investing, insurance, standards of living, renting or home ownership, and wills and trust plans.

# E. <u>CORE CURRICULUM OBJECTIVES ADDRESSED:</u>

**Communications skills**—to include effective written, oral and visual communication **Critical thinking skills**—to include creative thinking, innovation, inquiry, and analysis, evaluation and synthesis of information

**Empirical and quantitative competency skills**—to manipulate and analyze numerical data or observable facts resulting in informed conclusions

**Personal Responsibility**—to include the ability to connect choices, actions, and consequences to ethical decision-making.

**Social Responsibility**—to include the demonstrated knowledge and competence, knowledge of civic responsibility, and the ability to engage effectively in regional, national, and global communities

## F. <u>STUDENT LEARNING OUTCOMES:</u>

- **G.** <u>STUDENT LEARNING OUTCOMES ASSESSMENT:</u> This will vary and is geared towards Task Stream and WECM standards. This course will be assessed on an annual basis.

## H. <u>ATTENDANCE POLICY:</u>

As an online class, students must access the course on a regular basis.

Minimum log in for the course is at least four (4) days per week. Additionally, you should not let more than 72 hours pass without logging in. Students will be administratively withdrawn from class if there is no log in activity for a two-week period and/or no assignments completed during a two-week period.

The Blackboard software used to manage this online course tracks student logins, tracking when and where the student has been in the course. Accessing this course on a regular basis is extremely important in order to meet the objectives of this course. Ideally, students should daily check the semester schedule, e-mail, and also check for announcements and fellow student discussions. This course is not 100% self-paced—<u>there will be deadlines</u>. You will feel more at ease with the materials if you stay in touch with what is going on. This course is 3 semester credit hours. For this reason, you should set aside a minimum of 6 hours per week to work on this course. One of the very first things you should do is set aside time each week to work on the class. It is very easy to put off attendance in an online course.

A student who does not meet the attendance requirements of a class as stated, and does not officially withdraw from that course by the official census date of the semester, <u>may be</u> administratively withdrawn from that course and receive a grade of "X" as determined by the instructor.

An "F" will not be assigned to any student administratively withdrawn from a course for non-attendance by an instructor.
