**Course Title:** Principles of Macroeconomics

**Course Description:** An analysis of the economy as a whole including measurement and determination of Aggregate Demand and Aggregate Supply, national income, inflation, and unemployment. Other topics include international trade, economic growth, business cycles, and fiscal policy and monetary policy.

**Prerequisite:** None. However, its preferred that students have taken or are currently enrolled in MATH 1324.

- 1. Explain the role of scarcity, specialization, opportunity cost and cost/benefit analysis in economic decision-making.
- 2. Identify the determinants of supply and demand; demonstrate the impact of shifts in both market supply and demand curves on equilibrium price and output.
- 3. Define and measure national income and rates of unemployment and inflation.
- 4. Identify the phases of the business cycle and the problems caused by cyclical fluctuations in the market economy.
- 5. Define money and the money supply; describe the process of money creation by the banking system and the role of the central bank.
- Construct the aggregate demand and aggregate supply model of the macroeconomy and use it to illustrate macroeconomic problems and potential monetary and fiscal policy solutions.
- 7. Explain the mechanics and institutions of international trade and their impact on the macroeconomy.
- 8. Define economic growth and identify sources of economic growth.
- 9. Address issues, policies, public opinions, expectations, environmental, and cultural changes that affect industry, society, choices, and the current economic state.

**Student Learning Outcomes Assessment:** This will vary and is geared towards TaskStream and SACSCOC. This course will be assessed on an annual basis.

**Attendance Policy:** Students are expected to attend all classes in order to be successful in a course. The student may be administratively withdrawn from the course when absences become excessive as defined in the course syllabus.

A student who does not meet the attendance requirements of a class as stated in the course syllabus and does not officially withdraw from that course by the official census date of the semester may be administratively withdrawn from that course and receive a grade of "X" or "F" as determined by the instructor. Instructors are responsible for clearly stating their administrative drop policy in the course syllabus, and it is the student's responsibility to be aware of that policy.

It is the student's responsibility to verify administrative drops for excessive absences through MySPC using his or her student online account. If it is determined that a student is awarded

Each quiz will be due on Sunday, at midnight (EST), the week the quiz open ups.

**Case Study Discussion:** During the course, you complete a Case Study Discussion worth 5% of your final grade.

For the Case Study Discussion, you will read a case study related to a topic pertaining to the course and type 2-3 paragraphs answering assigned questions. You are also expected to make at least 2 thoughtful and substantial responses to classmates. A detailed rubric regarding the discussion will be located in Blackboard.

**Exams:** There are three major exams in this course and an optional cumulative final exam. Each of the three exams will be counted as 25% of your final grade (75% total), and the lowest exam can be replaced with the grade of the optional cumulative final exam. No make-up exams will be provided. Any missed exam will be replaced with the grade of the cumulative final exam, no exception. The instructor will announce the details prior to the exam.
