#### **Course Evaluation:**

Course grade will be assessed according to the completion of the following using percentages noted:

Major Presentations30%Exams, Projects, Daily Work, Class Participation70%

**Attendance Policy:** Students are expected to attend all classes in order to be successful in a course. The student may be administratively withdrawn from the course when absences become excessive as defined in the course syllabus.

When an unavoidable reason for class absence arises, such as illness, an official trip authorized by the college or an official activity, the instructor may permit the student to make up work missed. # **Specific Attendance Policy Restated**

- 1. All students enrolled for this course are expected to attend class regularly, be on time, and remain until
- 2. Roll will be taken at each class meeting.
- 3. If a student is tardy, he/she should speak with the instructor after class to avoid having tardies count toward absences.

If, according to the instructor's discretion, the student is allowed to make up such a presentation or exam, the student may receive a late penalty for the assignment.
