SOUTH PLAINS COLLEGE IMPROVES EACH STUDENT'S LIFE

I. GENERAL COURSE INFORMATION:

A. Course Description: Presentation of general principles of sound in air, characteristics of sound in recording and sound reinforcement applications. Topics include acoustical properties of studios, live performance facilities, resonances, and electronic and acoustic control.

B. End-of-Course Outcomes: Upon completion of this course, the student will:

- a. demonstrate knowledge of specific characteristics of sound in air.
- b. exhibit understanding of acoustical properties of halls, rooms, and studios.
- c. demonstrate an understanding of sound measurements.
- d. demonstrate ability to properly use audio measurement tools.

C. Course Competencies: Upon successful completion of this course, each student will have demonstrated through comprehensive examinations, quizzes and assignments; with a score of 60% or better, a competent understanding of: the origins, measurement and transference of sound in multiple mediums. The student will be able to calculate Sound Absorption Coefficients at multiple frequencies for commonly used building and acoustical materials. SCANS competencies will be met by the student: learning to take notes in class, working with fellow students, showing an understanding of the physics of sound, and choosing the correct formulas to compute sonic wavelengths, reverberation times and standing waves, choosing correct formulas, and turning in papers and tests in a timely manner.

D. It is the aim of the faculty of South Plains College to foster a spirit of complete honesty and a high standard of integrity. The attempt of any student to present as his or her own any work which he or she has not honestly performed is regarded by the faculty and administration as a serious offense and renders the offender liable to serious consequences, possibly suspension. F. Verification of Workplace Competencies- This course is a fundamental building block for the student to move toward a Capstone Experience. The course will also transfer to a senior level institution that offers a Recording Technology major.

II. SPECIFIC COURSE/INSTRUCTOR REQUIREMENTS

A. Textbook: *Master Handbook of Acoustics*, Sixth Edition F. Alton Everest and Ken C. Pohlman

B. Attendance Policy: In compliance with the general attendance policy of South Plains College, any student who fails to attend class for two consecutive weeks may be withdrawn from the course at the instructor's discretion. However, students who stop attending class without dropping the course at the Registrar's Office risk receiving an F in the class. Two absences may occur without penalty. Each absence after the first two will result in a 10% deduction off of the final grade. Cumulative absence penalties that result in a 59% or lower overall grade will result in being dropped from the course or a final grade of F, at the instructor's discretion. The only excused absences are for those students who are involved in an SPC event. These must be cleared with the instructor prior to the absence. This attendance policy is in effect whether a student in attending in person or via live streaming. Any other accommodations for course work must be approved by the instructor in advance. Please contact the instructor by voice mail or email if you are not able to attend the class for any reason before or the day of the expected absence.

C. Assignment Policy: Projects and reading assignments will be announced at least one class meeting prior to responsibility for material.

D. Grading Policy: Three equally weighted tests will count for 30% of the final grade. A final exam will account for 10% of the final grade. Quizzes will account for 20% of the final grade. Lab assignments will account for 15% of the final grade. Lab assignments may be arranged outside of normal class time. Written assignments will account for 15% of the final grade. Professionalism will account for 10% of the final grade. All written tests will be announced at least one week before the examination.

Students will be allowed to take exams early with permission from the instructor.

ADDENDUM

ATTENDANCE POLICY (Official SPC Catalog)

Students are expected to attend all classes in order to be successful in a course. The student may be administratively withdrawn from the course when absences become excessive as defined in the course syllabus.

When an unavoidable reason for class absence arises, such as illness, an official trip authorized by the college or an official activity, the instructor may permit the student to make up work

A student who does not meet the attendance requirements of a class as stated in the course syllabus and does not officially withdraw from that course by the official census date of the semester, may be administratively withdrawn from that course and receive a grade of "X" or "F" as determined by the instructor.
