Course Title: College Algebra

Course Description: In-depth study and applications of polynomial, rational, radical, exponential and logarithmic functions, and systems of equations using matrices. Additional topics such as sequences, series, probability, and conics may be included.

Prerequisite: Minimum score of 350 on the TSIA1, minimum score of 950 on the TSIA2, a diagnostic score of 6 on the TSIA2, TSI-exempt status, a successful completion with a grade of 'C' or better in MATH 0320, or successful completion of NCBM-0114.

Credit: 3 Lecture: 3 Lab: 1

Student Learning Outcomes: Upon completion of this course and receiving a passing grade, the student will be able to:

- 1. Demonstrate and apply knowledge of properties of functions, including domain and range, operations, compositions, and inverses.
- 2. Recognize and apply polynomial, rational, radical, exponential and logarithmic functions and solve related equations.
- 3. Apply graphing techniques.
- 4. Evaluate all roots of higher degree polynomial and rational functions.
- 5. Recognize, solve and apply systems of linear equations using matrices.

Student Learning Outcomes Assessment: Students must take a written end-of-semester assessment (final exam) covering the information from this course.

Course Evaluation: There will be departmental final exam questions given by all instructors.

Assignments and Grading:

Homework assignments will be assigned each class day and will be due on the quiz/exam day of the following week at class time. You will scan and save your homework as a pdf and then upload your completed homework into Gradescope on or before the due date/time. Each homework assignment is worth 0.3 points.

Quizzes will be given weekly on non-exam weeks and **no makeup quizzes will be offered**. To receive credit, all work for each problem must be shown. Each quiz is worth 4 points. Missing a quiz will result in 0 points for that quiz.

Exams will cover material from previous sections. Four exams will be worth 10 points each and the comprehensive final exam will be worth 20 points. There are no makeup exams. If you miss an exam, your final exam grade may be used to replace a missed exam. The final exam is mandatory to complete the course. Your final point value will determine your letter grade for this class and will

be determined by the following scale:
