Course Structure: This is a hybrid/flex course. This section will be held in a <u>flipped format</u>. That is, students are required to watch the instructor-made lecture videos found on Blackboard <u>prior</u> to class each day. In class, students may ask questions and get clarifications on any topics covered in the lecture videos. Assessments, such as labs, quizzes, and exams, will all be done in class. All students are expected to be physically in class unless given explicit permission to be virtual.

Textbook: This section does NOT require you to purchase a physical textbook. All resources are online through MyMathLab (the online homework system - MML) or in your class notes found on Blackboard. You can purchase a physical copy of the book if you desire, but an electronic copy is available online after you gain access to MML.

Course Requirements/Materials: To maximize the potential to complete this course, a student should attend all class meetings, take notes and participate in class, and complete all homework assignments and examinations including the final exam in the allotted time. All students are expected to have reliable internet access, a reliable laptop or tablet, a printer, and either a scanner or a smart phone for submitting PDF documents. Students will also need to purchase the access to MyMathLab after the 14-day free trial period ends.

The MATH 0324 final grade is at the discretion of the instructor and is only a Pass/Fail grade.

Class Notes: All class notes can be found on Blackboard. These are just an outline and are to completed by the students while watching the lecture videos. I highly recommend printing the documents before watching the lecture videos. <u>Students are also expected to bring these completed notes to class each day.</u> I recommend keeping a 2-inch binder for this course.

Lecture Videos: All lecture videos can be found on Blackboard. Students are expected to have watched the lecture video(s) assigned for each day on the tentative calendar, filled in the class notes, which are also found on Blackboard, and have organized questions to ask in class each day over the lesson(s) assigned. All of this must be done **PRIOR** to attending class.

^{***}Note: Students must justify answers or show work on all problems to receive full credit.

Homework: All homework assignments will be on MyMathLab, an online homework system, that is access through Blackboard. Homework is to be completed by the due dates posted on each assignment. No late homework will be accepted. The use of any mathematical solving apps/programs (i.e. PhotoMath, etc.) is strictly prohibited and can result in academic dishonest proceedings. All work in this class must be your own!! Three low homework grades will be dropped at the end of the semester.

Labs/Quizzes: There will be some kind of assessment (lab or quiz) each class, time permitting. For labs, students can use their class notes on the assignments. For quizzes, students can use one 3x5 note card, hand-written by the student taking the quiz. Labs and quizzes are expected to be completed before the end of the class each day.

Tests: There will be a total of 5 exams in this course. No notes/homework/textbooks will be allowed on ANY exam. All exams are expected to be completed in the allotted class time, no exceptions. No exam grades will be dropped. Exam corrections are for your own learning well-being and will not be graded but are expected to be completed after each exam is returned. You will get all of your midterm exams back. It is in your best interest to save ALL graded documents until your final grade is assigned at the end of the term. Exams may be comprehensive.

Final Exam: There are TWO final exams for these courses, one for Math 0324 (P/F) and one for Math 1324 (college-level). The final exams are each comprehensive. Any student who does not take the final exams will fail the classes with F's regardless of the student's average. No make-up final exams will be offered. The final exams will be held on Tuesday, May 10th from 8am to 10am and Thursday, May 12th from 8am to 10am. Wait for more details to be shared on Blackboard near the end of the term.

Bonus Tests: There are weekly bonus tests on MyMathLab. If you complete these tests, you can earn up to 5 percentage points added to your final grade. These tests are optional but they are timed and they do expire at the end of each week. The average of your bonus test scores will determine the number of points added to your final average (i.e. If you average 80% on the bonus tests, then you will be awarded 80(0.05) = 4 points to your final average.) Any bonus test you skip will be scored as a 0.

Late work: Late work is not accepted. If you do not turn in an assignment on time, you will receive a zero.

Make-up: Make-up work is given at the discretion of the instructor. NO make-up labs, quizzes, or tests are given without <u>prior notification AND proper documentation.</u> If you are absent from class, have given prior notification and proper documentation of your absence, you MUST make arrangements to take the lab, quiz, or exam BEFORE the next class period. Students who do not take labs, quizzes, or exams in-class, early or late, forfeit the right to attempt any extra credit on that quiz or exam.

SPC Attendance Policy: Attendance and engagement are the most critical activities for success in this course. The instructor maintains records of the student's attendance and submission of assignments throughout the semester. The student is expected to attend at least eighty percent (80%) of the **total** class meetings **and** submit at least eighty percent (80%) of the **total** class assignments to have the best chance of success. If the student fails to meet these minimum requirements, the instructor <u>may</u> remove the student from the class with an X, upon their discretion, to help the student from harming their GPA.

Furthermore, unless given specific permission, students are expected to be IN THE CLASS ROOM and on time for class each class day. If any student abuses the virtual component of this course, the instructor has the right to drop the student with an X, depending on the instructor's discretion. That is, if a student doesn't attend class in person for an extended period of time as determined by the instructor,

that student is subject to being dropped from the course by the instructor. <u>There are no excused absences</u>, even with a doctor's note.

Any student who arrives more than 10 minutes late or leaves early without permission will be counted tardy and 25% of their participation grade that day will be deducted. Any student who falls asleep during class or who leaves class for an extended period of time, as determined by the instructor, will have 25% or more of their participation grade deducted for that day.

Participation Grade: Every day, there will be a participation grade. This grade is 50% attendance to/participation in class and the remaining 50% is awarded for watching the lecture video(s) prior to class and filling in the lecture notes. Students are required to submit their completed written notes on Blackboard after completing the lecture videos but PRIOR to class each class day to get this credit. The notes should be in a single PDF file when uploaded. Students are also expected to bring all class notes with them to class every day. If the student does not come to class prepared (with notes), then that student forfeits the right to ask for assistance from the instructor and other students on any assignments or class lectures that day. In the event you are absent during class, you will get 0 pts for the Attendance/Promptness portion of this grade for that day.

Submitting Documents Online: Students will be required to upload their completed notes to Blackboard. This is expected to be done as a single PDF file that is clear and legible. Students are allowed to use whatever hardware/software they desire to create the PDF files, but here are a few suggestions:

App: **GeniusScan** – need a Google email to do this for free

App: CamScanner – limit on number of pages that can be compiles on the free version

Apple Phone – has a program on it already that will compile pictures into PDF files

Academic Integrity: Any student involved in cheating will receive a zero on the assignment(s) and will be informed of why he/she received a zero. In the event of a second offense, guilty students will be dropped from the course with an F and an academic dishonesty report will be filed against the student, which goes on the student's permanent school record.

Calculators: There will be times throughout the year when students will need a graphing calculator to complete an assignment. This course is taught under the assumption that each student owns a graphing calculator. I recommend a TI 84 series calculator. TI-Nspires are NOT recommended unless you are an expert at using them, as the instructor will be of little help. <u>There are no calculators</u> allowed at all until unit 3.

Class Rules:

- Be on time and ready to learn.
- Use only pencil for all assignments.
- Students are not permitted to use electronic devices, other than a calculator, in class. **Put** the cell phones away!!

Virtual Students: In the event you are joining class virtually, you are expected to stay active and attentive during the entire class. You are also expected to keep your camera on until you have explicit permission from your instructor to turn it off. Your cell phone should be on silent, face down but in view of the camera during the entire assessment. Students are expected to follow the same testing/quizzes/lab rules as any student in class. If you leave the view of the camera during an assessment without explicit permission from the instructor, you will be given a 0 on the assessment. If you break any of the rules listed above, you will receive a 0 on the assessment. Also, students are expected to keep their chat windows open during assessments as a way for the instructor to communicate (quietly) with each student. If the student does not keep their chat window visible to themselves during assessments and misses a message from the instructor, 15% credit will be deducted from that assignment's score.

Students who are virtual for an assessment have been given explicit permission by the instructor to take the assessment in this format. If you are not given this permission, you are expected to be in class for each and every assessment (labs, quizzes, tests). Instructor permission is not given lightly nor liberally and the decision to allow a student to work virtually is entirely at the instructor's discretion.

To submit work virtually, students must upload a single PDF document of their work using an app such as **GeniusScan**, or similar. It is the student's responsibility to ensure the document is legible and in the correct format. Any assignment not submitted in the correct format will be given a 0 on the assignment. Assignments will usually be uploaded to Blackboard, but can be e-mailed with instructor permission.

Course Description: Math0324 is to be taken concurrently with MATH 1324. Background topics which are necessary for a student to successfully complete MATH 1324 will be covered, with an emphasis on fractions, factoring polynomials, functions, exponents, and operating with radical expressions. Math 1324: The application of common algebraic functions, including polynomial, exponential, logarithmic, and rational, to problems in business, economics, and the social sciences are addressed. The applications include mathematics of finance, including simple and compound interest and annuities; systems of linear equations; matrices; linear programming; and probability, including expected value.

Prerequisite: Minimum score of 340 on the TSIA, or a successful completion with a grade of 'C' or better in MATH 0315.

Credit: 3/3 Lecture: 3/3 Lab: 1

Textbook: *Mathematics with Applications in the Management, Natural, and Social Sciences*, Lial, Hungerford, Holcomb, and Mullins, 2019, 12th Edition, Prentice Hall/Pearson Education
