## SOUTH PLAINS COLLEGE IMPROVES EACH STUDENT'S LIFE

<u>Course Description</u>: An introduction to the basic principles of regulators, reclosers, and capacitors. Topics will include the internal construction of each device, installation techniques, principles of operation, troubleshooting techniques, and the safe restoration of service to such devices.

Course Learning Outcomes: The goals/objectives of this course are:

Regulator, recloser and capacitor functions; internal construction; basic operating principles.

<u>Course Competencies:</u> Upon successful completion of this course, each student will have demonstrated through comprehensive examinations, with a score of 70% or better, a competent understanding of:

Regulator, recloser, and capacitor requirements

Regulator, recloser, and capacitor operation.

It is the student's responsibility to complete work missed within a reasonable period of time as determined by the instructor.

- \*\*Attendance is taken daily and accrues three points per class attendance. A total of 100 points is possible.
- \*\*\* Final Examination is required for all students.

Proof of a positive test is required. A home test is sufficient but students must submit a photo of the positive result. The date of test must be written on the test result and an ID included in the photo. If tested elsewhere (clinic, pharmacy, etc.), please submit a copy of the doctor's note or email notification. A student is clear to return to class without further assessment from DeEtte Edens, BSN, RN if they have completed the 5-day isolation period, symptoms have improved, and they are without fever for 24 hours without the use of fever-reducing medication.

Students must communicate with DeEtte Edens, BSN, RN prior to their return date if still symptomatic at the end of the 5-day isolation.

<u>Special Requirements</u>: Safety Policy. Students should adhere to safety standards established in the SPC Student Handbook.
