## **GENERAL COURSE INFORMATION:**

<u>Course Description</u>: Instruction in commercial wiring methods will be discussed. Topics can include wire sizing, equipment selection, and calculations applicable to electrical installation.

<u>Course Learning Outcomes</u>: The goals/objectives of this course are:

Student will interpret electrical blueprints and drawings. Compute the circuit sizes and overcurrent protection needed for the installation of branch circuits. Explain the proper installation of wiring devices. Demonstrate grounding methods. Identify commercial wiring methods.

A student is clear to return to class without further assessment from DeEtte Edens, BSN, RN if they have completed the 5-day isolation period, symptoms have improved, and they are without fever for 24 hours without the use of fever-reducing medication.

Students must communicate with DeEtte Edens, BSN, RN prior to their return date if still symptomatic at the end of the 5-day isolation.
