#### SOUTH PLAINS COLLEGE IMPROVES EACH STUDENT'S LIFE

<u>Course Description</u>: This course is an introduction to mathematical applications utilized to solve problems in the electrical field. Topics include fractions, decimals, percentages, simple equations, ratio and proportion, unit conversions, applied geometry and utilization of right triangles to calculate electrical values.

<u>Course Learning Outcomes</u>: The goals/objectives of this course are: Students learn to utilize a calculator to perform operations involving fractions and decimals. Compute percentages utilizing ratio and proportions. Solve simple equations. Calculate areas and volumes of geometric solids. Utilize right triangles to calculate electrical values.

<u>Academic Integrity</u>: The attempt of any student to present as his or her own work which he or she has not honestly performed is regarded by the faculty and administration as a most serious offense and renders the offender liable to serious consequences, possibly suspension. A student is clear to return to class without further assessment from DeEtte Edens, BSN, RN if they have completed the 5-day isolation period, symptoms have improved, and they are without fever for 24 hours without the use of fever-reducing medication.

Students must communicate with DeEtte Edens, BSN, RN prior to their return date if still symptomatic at the end of the 5-day isolation.
