<u>Course Description</u>: An introduction to basic transformer connections and theory including basic alternating current (AC) theory and their direct application to single phase and three phase transformers. Students will study and practice basic transformer connections and fundamentals.

<u>Course Learning Outcomes</u>: The goals/objectives of this course are:

Students will explain basic single-phase transformer operations and basic electrical values such as polarity, impedance, current, resistance, and inductance in AC system transformers.

A student is clear to return to class without further assessment from DeEtte Edens, BSN, RN if they have completed the 5-day isolation period, symptoms have improved, and they are without fever for 24 hours without the use of fever-reducing medication.

Students must communicate with DeEtte Edens, BSN, RN prior to their return date if still symptomatic at the end of the 5-day isolation.
