<u>Course Description:</u> This course gives instruction in wiring methods for single family, two family, and multi-family dwellings. Topics include wire sizing, installation techniques, and calculations necessary for electrical installations.

<u>Course Learning Outcomes:</u> Students will compute the circuit sizes need for the installation of branch circuits, feeders, and service entrance cables. Explain the proper installation of wiring devices according to electrical codes.

Demonstrate grounding methods. Install ground fault circuits. Identify residential wiring methods.

<u>Course Competencies:</u> Upon successful completion of this course, each student will have demonstrated through comprehensive examinations, with a score of 70% or better, a competent understanding of: The methods and skills necessary for residential wiring. Calculations used in residential wiring. Codes applicable to residential wiring.

<u>Academic Integrity:</u> The attempt of any student to present as his or her own work which he or she has not honestly performed is regarded by the faculty and administration as a most serious offense and renders the offender liable to serious consequences, possibly suspension. If you have a question as to whether you may work with other students on any assignment, ASK YOUR INSTRUCTOR.

A student is clear to return to class without further assessment from DeEtte Edens, BSN, RN if they have completed the 5-day isolation period, symptoms have improved, and they are without fever for 24 hours without the use of fever-reducing medication.

Students must communicate with DeEtte Edens, BSN, RN prior to their return date if still symptomatic at the end of the 5-day isolation.
