**Attendance Policy:** Punctual and regular attendance is required of all cosmetology students. Unexcused tardiness and absences will not be tolerated. A doctor's note is required stating that it is acceptable to return to school in cases of contagious diseases such as pink eye, strep throat or the flu. If 5% of this course is missed the student will have to attend mandatory makeup days. If a student refuses to attend makeup days he/she may be at risk of being withdrawn due to excessive absences. The Class Attendance policies stated below is in the SPC General Catalog:

[Students are expected to attend all classes in order to be successful in a course. The student may be administratively withdrawn from the course when absences become excessive as defined in the course syllabus.
